

First Global Bank "Match Your Spend" Promotion FAQs

General Information

Q1: What is the "Match Your Spend" promotion?

A1: The "Match Your Spend" promotion is an exciting offer from First Global Bank where customers who use their Visa Classic or Visa Gold Credit Card to make purchases of \$25,000 or more between June 7 and September 9, 2024, can enter for a chance to win back the value of their purchase in cash back.

Q2: When does the promotion period start and end?

A2: The promotion runs from June 7, 2024, to September 9, 2024.

Q3: How can I enter the promotion?

A3: To enter, simply use your First Global Bank Visa Classic or Visa Gold Credit Card to make a purchase of \$25,000 or more during the promotion period.

Eligibility and Participation

Q4: Who is eligible to participate in the promotion?

A6: Any purchase of \$25,000 or more made with a First Global Bank Visa Classic or Visa Gold Credit Card qualifies. This includes purchases made at retail stores, online, or for services.



Q7: What is the prize for the promotion?

A7: Winners will receive cash back equivalent to the value of their qualifying purchase.

Q8: When will the winners be announced?

A8: The draw date for the promotion is September 10, 2024. Winners will be randomly selected and contacted to arrange for prize collection.
